



Certification fees for textile products to Global Organic Textile Standards (GOTS)

Application fees are payable on application and cover your application journey until your certificate is issued and your first 12 months of certification.

UK Application fee

Fees (for UK based operations) include your application inspection and all core services throughout the year.

Inspection fees and expenses for inspections outside the UK

In addition to the application/annual fee, inspection fees and expenses are added for inspections outside the UK. Please email <u>international@soilassociation.org</u> for a quotation/estimate.

Annual fees are based on your total organic certified sales each year and are payable on your annual renewal date.

Transferring from another certification body

We offer a discounted fee for businesses transferring from other certification bodies for the first year. We can help you to easily transfer your GOTS certificate to Soil Association Certification. This fee will be charged at the cost of the Certified Entity Annual Fee (payable to GOTS- see below table) and the cost of inspection for the first year. Any additional sites requiring inspection during this period are not included in this fee.

¹ Applicable where a licensee wishes to use another company to label their product with the SA Symbol and the company applying the symbol is not licenced by SA.

²As the standard owner GOTS collect an annual fee of €50 from the certifier and a Certified Entity Annual fee of €180 from the certified company, per site certified (including additional facilities and subcontractors). Because Soil Association is a founding member of GOTS and a member of the Global Standard GmbH, our licensees received a 50% reduction to the licence fee.

^{*}Subcontractor: entity in the supply chain performing job work (processing or manufacturing) for a certified entity without becoming proprietor of the GOTS goods and not assigning an own independent GOTS certification.

Additional inspections (for UK based operations)

If more than one day is required for an application or annual inspection, or an additional inspection is required during the year, these are charged at £550 per additional day.
